

- Dealer must have previously purchased at least one (1) truckload of ExpertFinish products in 2019/2020/2021/2022
- This rebate program applies to truckloads of ExpertFinish products purchased in 2023 only. LP SmartSide primed products and 3rd party prefinished products are NOT eligible
- · Offer is valid for stocking inventory purchases only; truckloads must deliver directly to dealer's location
- Dealer may submit multiple registration forms with corresponding sales documentation, but will receive no more than \$1,500/truck, up to 4 trucks (\$6,000 maximum per dealer location)
- · This rebate may not be combined with any other rebate or discount on ExpertFinish products
- All completed rebate forms and supporting documents must be received by December 31, 2023
- TAX ID AND SALES INVOICE ARE REQUIRED TO RECEIVE REBATE. All other forms of documentation will be denied
- · Sales invoice must show date of purchase, product description, and purchase price

PLEASE SUBMIT COMPLETED FORM AND INVOICE DOCUMENTATION ONLINE.

RULES: This rebate offer is made available to dealers repurchasing full truckloads of ExpertFinish products only. To qualify as a repurchase, the dealer must have purchased at least one truckload of ExpertFinish products in 2019/2020/2021/2022. Each rebate offer shall be subject to review and approval by LP and shall be subject to the terms and conditions of the rebate. This rebate applies only to product purchased between January 1, 2023 and December 31, 2023. Rebate is limited to 4 trucks per dealer location (\$6,000 max). This rebate is NOT available to distributors, buying groups, builders, contractors, or homeowners. Rebate checks will be issued to eligible dealers based upon the verifiable information provided on the registration form. Invoice must show date of purchase, product description, and purchase price. Failure to provide this information may result in the delay or denial of the rebate. LP is not responsible for incomplete, late, or misdirected submissions. Fraudulent submissions will be disqualified and could result in federal prosecution under the U.S. mail fraud statues (Title 18, USC 1341 and 1343). All forms and invoices must be received by December 31, 2023 to be eligible. Please allow 6-8 weeks for processing. Dealer is solely responsible for local, state, and federal taxes on any payments received. LP's decisions on any issues relating to this program are final. LP reserves the right to modify this program or terminate it at any time with or without notice. This offer is only available to dealers with mailing addresses in the United States and void where taxed, restricted, or prohibited by law.
